



As an affiliate of Globe, Ant Group (affiliate of Jack Ma's Alibaba), and Ayala, Mynt provides secure, accessible, and convenient fintech solutions to individuals, businesses, and organizations. It is recognized as the Philippines' first tech double unicorn with the support of its distinguished local and global shareholders.

Prior to Mynt, Sazon was Senior Vice President of Globe Telecom's broadband business. Before that, she was Marketing Director and Category Leader for Asia for GlaxoSmithKline Philippines, Inc., and Senior Product Manager for Del Monte Philippines, Inc. Sazon holds a Bachelor of Science in business administration and accountancy from the University of the Philippines.


